In this regard let us emulate what Deputy President Kgalema Motlanthe at the launch of the men's forum in Johannesburg. The Deputy President said real men do not abuse women and inflict pain on children. My colleagues will remember that the Municipal Finance Management Act N0.56 of 2003 does not mince words when spelling out the outcomes of people who commit wasteful and fruitless expenditure.

It is important to note that there is a difference between crafting a policy and implementing it. I'm saying this without any fear of contradiction because most of these policies we are reviewing today have not been fully implemented.

Let us from now onwards begin a new chapter and develop a new culture of ensuring that all policies, programmes and projects can find their way to the full implementation.

In conclusion, I must take this opportunity of welcoming you all to this important session of our municipality.

I want to believe that the outcome of the proceedings of these few days will make a difference in terms of our institutional capacity on matters related to policy development and policy implementation.
