# 10.1 <u>INVESTIGATION REPORTS CONDUCTED BY ETHICS COMMITTEE AND PRIVATE</u> INVESTIGATOR ON THE MAYORAL VEHICLE ACCIDENT

#### **PURPOSE**

To table reports of investigations conducted for the Mayoral Vehicle accident to Council for consideration

To present an investigation report for Council approval that was conducted by the Private Investigator appointed by the Council Speaker as an independent expert in consultation with the Municipal Manager to conduct an investigation into the causes of and general circumstances pertaining to the damages of the vehicle.

To present investigation report that was compiled by the Rules and Ethics committee in establishing facts and causes of the Mayoral Vehicle accident.

To present findings and recommendations of the investigations conducted by Ethics committee and Private Investigator to the Council for consideration and approval.

#### **AUTHORITY**

The Constitution of the Republic of South Africa, 1996 as amended The Municipal Structures Act 117 of 1998 as amended The municipal Systems Act 32 of 2000; Schedule 1 The Municipal Delegation Framework Municipal Mayoral Vehicle Policy

#### LEGAL AND STATUTORY REQUIREMENTS

The Constitution of the Republic of South Africa 108 of 1996, makes various calls for ethical behaviour by municipal councillors. Section 195 of the Constitution stipulates that public administration must be conducted with the democratic values and principles enshrined in the Constitution.

The Municipal Structures Act 117 of 1998; Section 79 of the Municipal Structures Act stipulates that a Council may establish one or more committees necessary for the efficient and effective performance of any of its functions.

The Local Government Municipal Systems Act 32 of 2000; Item 14(1)(b) of Schedule 1 states that a municipal Council may establish a special committee to investigate and make a finding on any alleged breach of the Code of Conduct for Councillors and to make appropriate recommendations to Council.

Code of Conduct for Councillors – Schedule 1; Paragraph 2. General Conduct of Councillors:

(a) to perform the functions of office in good faith, honestly and a transparent manner; and (b) at all times act in the best interest of the municipality and in such a way that the credibility and integrity of the municipality are not compromised.

**Paragraph 12. Council Property;** A councillor may not use, take, acquire or benefit from any property or asset owned, controlled or managed by the municipality to which that councillor has no right.

Paragraph 14. Breaches of the Code; Section (1) a. b. and section (2)

#### BACKGROUND AND REASONING

On the 28 May 2020 the Umzimvubu Local Municipality Council took a resolution that the Ethics Committee should embark on the investigation of the Mayoral Vehicle accident that occurred on the 27 April 2020. The accident occurred along N2 road in the jurisdiction of Mhlontlo Local Municipality.

The Ethics committee was expected to report directly to the Council regarding its findings and recommendations after finalising the investigation.

The Mayoral Vehicle Policy in section 6.13, mandated the Speaker to appoint an independent expert in consultation with the Municipal Manager to conduct an investigation into the causes of and general circumstances pertaining to the damages and cause of the accident.

Section 6.14 of the Municipal Vehicle policy states that the independent expert will draw findings and make recommendations with regard to the damages to a mayoral vehicle and submit report to the Speaker.

The Private Investigator will be presenting the report submitted to the Speaker with findings and recommendations to the Council for consideration and approval.
