  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favorable arrangements due to such cancellation;
  - (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the audi alteram partem (hear the other side) rule has been applied; and
  - (e) Forward the matter for criminal prosecution.

### TRAINING WORKSHOP OF UMZIMVUBU WARD COMMITTEES ON MUNICIPAL GOVERNANCE

### 1. TARGET GROUP

One hundred and sixty (160) Ward Committees from kwaBhaca wards.

### 2. OBJECTIVE AND CONTENT OF THE WORKSHOP

The purpose of this training is to enable the Ward Committees to understand their roles in municipal processes, community participation service delivery implementation.

### 2.1. The content should cover but not limited to the following aspects:-

- Display an understanding of the policy and legal framework guiding the Ward Committee system and its functioning.
- Demonstrate an understanding and apply the broad principles of Ward Committee functioning to participate in municipal processes (community based planning, IDP and Budget.)
- Support the facilitation of development project monitoring in a Ward Committee context.
- Development and implementation of Ward Operational Plans.
- The involvement of communities in all municipal and government programmes
- Application of communication, interpersonal and conflict management principles in Ward Committee functions.
- Facilitation of Service Delivery in a Ward Committee context.
- Facilitation of relations between Local Government and citizens to effectively support the implementation of its objectives.
- Principles of working relations between the Ward Committees, Community Development Workers (CDWs), and Traditional Leadership at a ward level.

### 3. METHODOLOGY

- 3.1 The session should be engaging and interactive.
- 3.2 Feedback and tips for improvement should be given to each of the participants.
- 3.3 All participants should be given training material.
- 3.4 A detailed close-out report for the work done should be submitted at least one week after completion of the work.
