Let me greet you all in the name of Jesus Christ, Amen.

Ladies and Gentlemen; during the month of September we celebrate all the men and women who have kept our traditions alive. We celebrate the crafters, the sculptures, the weavers, the musicians, the poets, the writers, the storytellers, the trackers, the healers and most importantly the indigenous languages and cultures within Umzimvubu; AmaXesibe kunye namaBhaca.

Heritage doesn't only find expression in dress, rituals, food, music, art and language. It also finds expression in our natural world. It is the inheritance passed down from generation to generation, linking the present to the past.

This year's Heritage Day Celebrations took place in the shadow of the COVID-19 pandemic. This pandemic has taken a toll on human life, on communities and on our economy.

However since the progression to level 2 of the lockdown, the country has seen the opening of tourism activities. This has also brought about a long awaited economic relief to our local accommodation establishments.
