### Scope and Extent of work

#### 1. 1. The Ploughing mechanization will be as follows:

The successful Service Provider shall be expected to conduct the following activies:

- Ploughing of 10 hectares of yellow maize fields.

Please note that the planting population of 35000 kernels per hectare will highly recommended. The main project output is ploughing of 10 hectors of maize fields in the above-mentioned wards. The seed bed must be prepared in such way that the planting is done on a flat land. Good quality seed bed must be used, and the project will be monitored closely from time to time or on each stage of operation. The service provider is expected to rip, 2 x disks, plant, pre- spray, post spray, broadcast and herbicides, pesticides, and fungicides application.
