Firstly, completion certificate signed by Project Manager, PSC Chairperson, Ward Cllr and LED Manager must be submitted with the payment certificate. Then the payment certificates will be signed by LED Manager, Project Manager, PSC Chairperson and ward Councilor as part of project management.
