1. TERMS OF REFERENCE TO “CONDUCT TRAINING ON HERITAGE SITES DEVELOPMENT”

1. BACKGROUND AND OVERVIEW OF THE PROJECT

1.1 INTRODUCTION

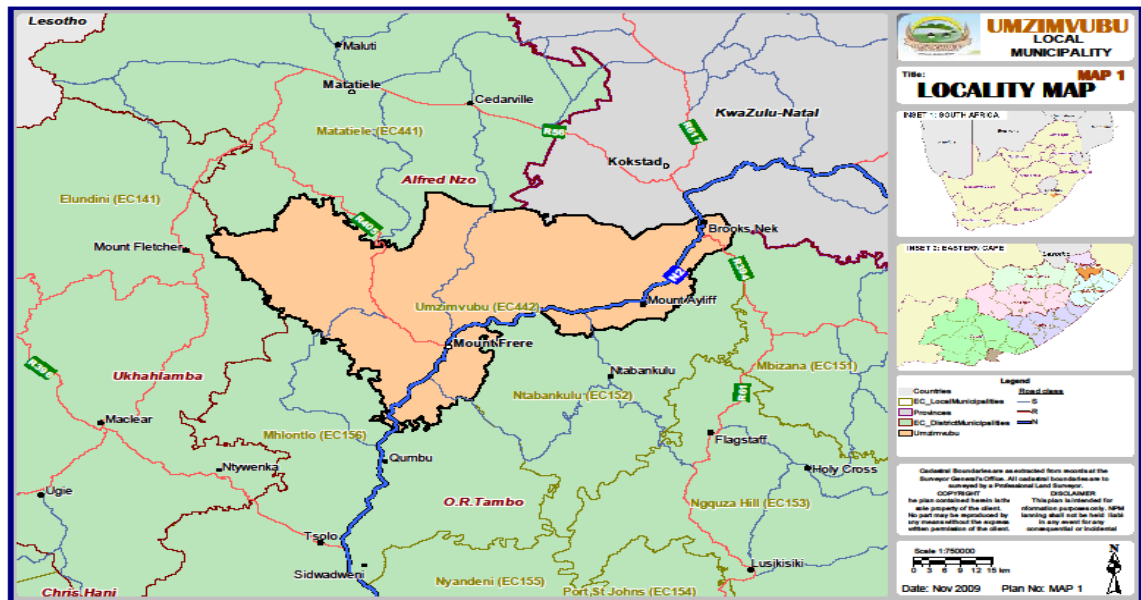


Figure 1.1: Alfred Nzo in the Eastern Cape Province and Umzimvubu Local Municipality

The Umzimvubu Local Municipality is within Alfred Nzo District Municipality (ANDM) which is located in the North-Eastern part of the Eastern Cape Province in South Africa, as shown in Figure 1.1 below. The District forms part of the Eastern Cape Province’s boundary with the Kwa-Zulu Natal province. The District borders the Kingdom of Lesotho to the north and the district of OR Tambo in the Eastern Cape and Harry Gwala District in Kwa-Zulu Natal. The Umzimvubu Local Municipality is constituted amongst the four local municipalities within the ANDM, others being Matatiele, Mbizana and Ntabankulu Local Municipalities.

Umzimvubu Local Municipality is located in one of the poorest regions of South Africa within the Alfred Nzo District Municipality in the northeastern part of the Eastern Cape Province. It stretches from a border with KwaZulu-Natal to adjacent municipalities of Matatiele, to the north, Ntabankulu and Mbizana to the South as well as Mhlonlto Local Municipality within the OR Tambo District Municipality to the west. The major national road, N2, passes through the municipality and it is one of the busiest transport and passenger routes in the country.

The locality of ULM is faced with a great number of socio-economic challenges. The region is characteristic of high poverty and unemployment levels and low education and skills level. The district possesses potential in tourism related opportunities as a result of a number of attributes namely its rich history, heritage and culture etc. have been well profiled in the Tourism Development Plan.

It is common knowledge that Mzimvubu Local Municipality as a whole is littered with historical cultural and heritage sites and places some of which are the result of resistance of wars of colonial dispossession and conquest. Others are sites of cultural significance that have shaped the value systems and cultural expressions of many centuries. Historians and other commentators have written a lot about these occurrences in this area, but not the intangible heritage legacy that has been bestowed upon these communities and the district as a whole.

The Mzimvubu Local Municipality has significant heritage attractions linked to the various layers of history relating to the San, Khoi, Xhosa, and the liberation struggle in more recent times.

In the South African context, the governance of heritage is premised in the main on two pieces of legislation namely: the National Heritage Council Act (NHC) 1999 and the National Heritage Resources Act (NHRA) 1999. The reason these two stand out is because they are the products of the protracted heritage policy formulation and the lynch pin around which an inclusive transformed heritage sector was predicated. National Heritage Council Act (RSA 1999) enabled the establishment of the NHC as a “juristic person” to develop, promote, and protect the national heritage, and to coordinate its management. The National Heritage Resources Act (RSA 1999d) provided for the establishment of the South African Heritage Resources Agency (SAHRA). SAHRA is the administration agency responsible for the protection of the cultural heritage of South Africa and has a much wider and more inclusive remit than its predecessor. It is expected to coordinate the identification, assessment, grading, registration, and management of heritage resources in the national estate, through an integrated and interactive system’.

1.2 OVERALL OBJECTIVE AND SPECIFIC OBJECTIVES OF THE PROJECT

1.2.1 Overall objective

The overall objective of the project is to conduct training for the Umzimvubu heritage sites for further development and improvement in both EmaXesibeni and KwaBhaca. These heritage sites can be classified as follows, but not limited to:

- i. Burial sites
- ii. Battle sites
- iii. Mission Stations
- iv. Colonial era Trading Stations and mines
- v. Natural Sites such as waterfalls, dams, natural indigenous forests, rivers, mountains or any sites of unique features

1.2.2 Specific Objectives

The specific objectives of the project require the undertaking of the following:

- Conduct training for the Umzimvubu heritage development in the following sites/areas namely:

- ✓ **Culture and history** of its major cultural groups: Bhaca, Xesibe, Hlubi and many other smaller communities.
- ✓ Burial sites: **Xesibe Paramount Chief Jojo** at eLubaleko village near his great place inside the high school yard (Daluhlanga SSS); Chief Fikeni burial place at Ndzongiseni near eMaXesibeni village town. Chief Jojo kaMjoli kaSinama who was born into the great upheavals of Mfecane and graduated into the perennial wars of Mhlangaso of the Pondos that lasted for almost the whole of the 19th century.
- ✓ **Ntsizwa Mountain** (formerly known as Nunge Mountain) where Shaka warriors suffered defeat with the help of snow that fell on the mountains and combined Xesibe and Bhaca warriors attacked and defeated them.
- ✓ **Ntsizwa Waterfalls:** These falls at eNgqubusini in Lugelweni Village are a natural phenomenon and the only waterfalls in the area. The river that feeds the falls never dry even during droughts and it used to be tourist centre for whites for much of the 20th century until their mass exodus in 1976 after the Transkei Bantustan independence
- ✓ **Ntsizwa Copper & Nickel Mine** which was operated by Canadian and Australian companies from 1890s until 1930s. This mine is located right next to the waterfalls and is reported to be more than 2km deep.
- ✓ **The July/August 1879 Battle of Umnweba** in Mnceba village and its surroundings was the bloodiest war between Pondos/Manci and Xesibe which left about 600 people dead and a new place called Ndlantaka was named to honour those bodies which were eaten by birds without being collected after the battle stalemate.
- ✓ **Isiziba Sikanopoyi:** The battle site where Pondo warriors drowned during battle with Bhaca who are reported to have doctored the war to cause "ilumbo" of a cow that ran towards pondos creating confusion among themselves.
- ✓ **Burial sites** of Jojo, Fikeni, William Nota, Mpondomise leader (Ntose) at Rode, former East Griqualand Magistrate, Frank Brownlee, Bhaca leaders, etc).
- ✓ **Memorial of liberation struggle icons** who come from Umzimvubu (Kongo Rebellion of 1940s and 1960 e.g. Mvaelwa who was jailed in Robben Island after leading that as well as Ntlabathi Jojo who was banished to eNqutu for 10years for his role in leading anti-trust or land-rehabilitation dispossession programme. This rebellion is placed by historians on the same scale of the much-publicized Pondo Rebellion of 1960.
- ✓ **Fort Donald** is the military barracks and fort erected by Donald Strachan battalion to prevent perennial wars between Pondo and Xesibe;

- ✓ **Simaka-Maka Mountain** is a place where a WWII bomber airplane went down and its wreckage remained there for decades before the scrap metal was taken away;
- ✓ **Goxe Caves:** The place is rich in history as it is tied to the Ntsizwa story. Cattle were hidden in the area when the Zulu army was attacking ama-Bhaca;
- ✓ **Ingele Mountain:** Ingele Mountain is where in 1950 an aeroplane crashed on its peak killing all its occupants;
- ✓ **Other sites** such as the Rode Valley Trading Station and Hotel/Post Office, Mission Stations such as Gillespie, Dutyini, Rode, those of Mt Frere, Osborne, those of Mt Ayliff such as Anglican and Roman Catholic.

2. SCOPE OF WORK

Tenders are invited from suitably qualified professional service providers to conduct training and submit a well-documented report and implementation plan on how culture and heritage can be utilized for economic development in the Umzimvubu area.

2.1 Project Duration

The appointed service provider will be expected to start immediately after signing an agreement with Umzimvubu Local Municipality and the project is expected to be finished within eight (8) weeks to twelve (12) weeks.

2.3 Project Activities

This project will be implemented and managed in the following manner/phases:

Phase 1: Conduct training on heritage sites identification and mapping:

- This will entail a number of activities such as identification of historical sites, interviewing persons with knowledge of these sites, identification and collation of information on these properties;
- This phase should include an analysis and recording of each site's history such reasons for the erection, its strategic purpose and its contribution to the overall cultural identity;

3. Company Expertise Required

The management of heritage resources requires intimate knowledge and experience in the heritage discipline and therefore the following expertise constitute the key components of this project:

3.1 Heritage policy framework: It is imperative that one of the members of the organisation or institute should worked in public sector entities for a period of no less than fifteen (30) years in heritage policy framework and development. He or she should have full grasp of heritage policy development and implementation especially in the post-Apartheid South Africa and exposure to international heritage framework under the auspices of the World Heritage Organisation (WHO) and related implementing agencies.

3.2 Heritage Resources Management: One of the members should at least have a post graduate degree in Heritage Studies and have worked in heritage institutions for a period of no less than ten (10) years in heritage resources management. It is expected that such an individual will have a full understanding of South Africa's heritage legislation and regulations especially the challenges of transformation of the cultural heritage landscape to reflect the new ethos of the democratic state.

3.3 Heritage economics: Heritage resources management is increasingly becoming seen and viewed through the lens of asset management hence the there is a growing body of knowledge in heritage economics. It is therefore important that one of the members should experience of no less that five (5) years in socio-economic research and a full grasp of heritage economics. Such an individual should have a full grasp of economic policy formulation and implementation therefore and its impact in heritage resources management.

3.4 Historian: He or she should have a post graduate degree in history of South Africa with a specific focus on the wars of dispossession and conquest in the Eastern Cape and other areas. In addition, he or she should have a deep analytical capability on the heritage resources that accrued out of these historical heritage sites in the district and the province in general and above all be associated with an institution of higher learning.

4. KEY DELIVERABLES OF THE PROJECT

It is envisaged that the outputs of this project will amongst other things result in the following:

- Conduct training on heritage sites identification and mapping.
- Conduct training on validation of heritage sites:

- Identification, documentation and profiling of each site by a competent researcher.
- Identification and development of socio-economic opportunities in all heritage sites and places of cultural significance.
- A process of identifying potential sponsors who could contribute to sites development in partnership with the local municipality.
- Bringing on board private sector entities in heritage resources management thus realizing the concept public private sector partnership in this sector.
- Application of latest technologies in the digitization of heritage sites in line with the 4IR.
- Implementation that include signage, erection of monuments or narrative plates/plaque, access roads to the sites, infrastructure for some of the sites.
- Submission of a proposal for these sites to be graded and declared as provincial and national heritage sites.
