VIP protection also known as close personal protection, refers to security measures taken to ensure the safety of VIP or the individuals who may be exposed to elevated personal risk because of their employment.

The aim of this training intervention is to ensure that Umzimvubu executive and other politicians are protected as they serve in risk portfolios and especially when they serving in special events, by professional employees with expertise.

#### **2. TARGET GROUP**

The Municipality have identified (3) employees.

#### **3. GOALS AND CONTENT OF THE TRAINING:**

Learners be able to provide static and close protection to designated persons while in transit.

##### **3.1 The content should cover but not limited to the following aspects:-**

- Close protection to designated persons in transit (US 244319)
- Protection to designated persons while embossing or debussing (US 244334)
- Organisation of a close protection team
- Law and power of arrest (SA)
- Personal protocol and etiquette
- CPR and emergency first aid
- Security advance party
- Static protection to designated persons (US 244317)
- Pedestrian escort to designated persons (US 244327)
- Details of a single bodyguard
- Physical training
- Advanced driving – collision avoidance and skid control
- Threat assessments
- Firearms handling

#### **4. DURATION**

This training has to be done and completed within a maximum number of ten (10) working days.

## **5. METHODOLOGY**

- 5.1 The course should be engaging and interactive.
- 5.2 The use of constructive feedback and tips for improvement should be given to the participants.
- 5.3 This training programme should be delivered at a specified National Qualification Framework (NQF) and Unit standard aligned in content.
- 5.4 The service provider must ensure that the competency assessment is done to the participants and there is submission of POEs.
