- (j) **“Rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

### 3 POINTS AWARDED FOR PRICE

## CERTIFICATE OF INDEPENDENT BID DETERMINATION

This Protocol Etiquette will complement professional knowledge with skills in diplomatic protocol to support your organisation. It will give practical insights that will improve your effectiveness in a wide range of settings.

## 2. Target Group

There are Fifty-five (55) Councillors to be trained.

## 3. Goal and content of the training

To ensure that Umzimvubu Local Municipality Councillors know and understand the code of conduct and able to facilitate Council and related meetings in a way that maximises participative processes for achieving Local Government objectives.

The content should cover but not limited to the following .:

1. Definitions
2. General Conduct of Councillors
3. Roles and responsibilities of Councillors
4. Attendance at Meetings
5. Sanctions for non -attendance of meetings
6. Disclosure of interest
7. Personal gain
8. Declaration of interests
9. Full-time Councillors
10. Rewards ,gifts and favours
11. Unauthorized disclosure of information
12. Intervention in administration
13. Council property
14. Duty of Chairpersons of municipal councils
15. Breaches of Codes
16. Application of Code to traditional leaders

## 4. DURATION

This training has to be done and completed within a maximum number of three (03) working days.

## 5. METHODOLOGY

- 5.1 The course should be engaging and interactive.

- 5.2 The use of constructive feedback and tips for improvement should be given to the participants.
- 5.3 This training programme should be delivered at a specified National Qualification Framework (NQF) and Unit standard aligned **242858** and **244186**.
