### **1. INTRODUCTION**

Umzimvubu Local Municipality falls within the Alfred Nzo District of the Eastern Cape Province. The Municipal area comprises an area of 2506 square kilometers. According to a study conducted by the Alfred Nzo District Municipality in 2009, there are 79 924 households in Umzimvubu Local Municipality. Umzimvubu Local Municipality is located along the N2 which links Mthatha and East London to the southwest and Kokstad and Durban to the northeast. Umzimvubu Local Municipality is bound to the southwest by Elundini Local Municipality to the North is Matatiele Local Municipality.
