The bid will be evaluated on 80/20 evaluation criteria. Specific Goals will be utilised where 10 Points will be allocated to 100% black owned companies, 5 Points to 100% youth owned and 5 points to be allocated to 100% Female owned companies (non-elimination item). Prices quoted must be firm and must be inclusive of VAT for vat vendors. Certified ID Copies of Managing Directors/ Owners. MBD forms 4, 6.1, 8, and 9 and Billing clearance certificate or statement of municipal accounts, affidavit, confirmation letter with declaration that a company does not owe municipal services for more than 90 days are compulsory submission. Bidders must be registered on CSD and provide confirmation of registration. No faxed, e-mailed, and late tenders will be accepted and take no responsibility for couriered documents. Certification of documents must be within a period of 90 days. Umzimvubu Local Municipality reserves the right not to appoint and value for money will be the key determinant.
