3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

80/20 or 90/10 $Ps = 80 (1 + \frac{Pt - P \max}{P \max})$ or $Ps = 90 (1 + \frac{Pt - P \max}{P\max})$

4. POINTS AWARDED FOR SPECIFIC GOALS
