CLIMATE CHANGE ADAPTATION STRATEGY AND MITIGATION TOOLS**

1. BACKGROUND AND DISCUSSION

- 1.1. Umzimvubu local municipality has identified and prioritized the need to develop a climate change response adaptation strategy for the municipality in response to the national climate change bill and the white paper as gazzetted.
- 1.2. Also responds to call as mandated by chapter 2 section 24 of South African constitution which specifically puts environmental rights into the context of sustainable of human health, stating “ everyone has the right to an environment that is not harmful to their health or well-being”, as well as recognizing the rights of future generations in the context of sustainable development by stating “and to have the environment protected , for the benefit of present and future generations, through reasonable legislative and other measures or strategies that prevent pollution and ecological degradation; promote conservation; and secure ecologically sustainable development and use of natural resources while promoting justifiable economic and social development.
- 1.3. Municipal systems Act (32 of 2000) also emphasizes on the role of the municipality to provide clean and safe environment that will promote sustainable development.
- 1.4. Climate change occurs naturally due to natural and human activities/ processes. Climate change also by large a anthropogenic phenomenon caused by human activities that change the energy balance of the earth system, leading to increased concentration of greenhouse gases such as carbon dioxide in the atmosphere which introduces climate change risks that pose threats to our water supplies, changing rainfall patterns, temperature increase, biodiversity loss and rise in sea level.
- 1.5. All these significant changes results in enlarged areas prone to malaria and other vector-borne diseases, reduction in crops and livestock production due to reduced proteins in grasslands biome thus negatively impacting the tourism sector as well as livelihoods of communities at large.
- 1.6.
