UMZIMVUBU LOCAL MUNICIPALITY EXTERNAL QUALITY ASSESSMENT OF THE INTERNAL AUDIT FUNCTION

INTRODUCTION OF THE PROJECT

To obtain services of a professional and suitable service provider to conduct an external quality assessment (5-year review) of the Umzimvubu Local Municipality Internal Audit Function.

OBJECTIVES OF THE PROJECT

The objectives of the external QA are:

- (a) To assess Internal Audit Unit's conformance with the IIA Standards and Code of Ethics.
- (b) To assess the efficiency and effectiveness of Internal Audit Unit activities in meeting the objectives and mission as defined in the Charter of Internal Audit Unit.

BACKGROUND

The Global International Standards 8.4 require external quality assessment (QA) of the internal audit activity to be conducted at least once every five years by a qualified, independent reviewer or review team from outside the organization.

The chief audit executive has developed a plan for an external quality assessment and discussed the plan with the Audit Committee. The Global Internal Audit Standards require that external assessment must be performed at least once every five years by a qualified, independent assessor or assessment team. The requirement for an external quality assessment may also be met through a self-assessment with independent validation.

Quality Assurance Assessment was last done by EC Provincial Treasury in 2018 and the report was issues to the municipality to implement recommendations and agreed upon action plans. The municipality's Internal Audit function is now due for External Quality Assurance Review.

Internal Audit Unit uses only excel spreadsheet for working papers and when conducting an audit. Reports and working papers are in the English language. For the year 2022/23, Internal Audit Unit has produced 21 audit reports.

SCOPE

The scope of this external assessment includes the following core components:

- a) The level of conformance with the Standards and Code of Ethics.
- b) The efficiency and effectiveness of the internal audit activity.
- c) The extent to which the internal audit activity meets expectations of the board (Audit & Performance Committee), Senior Management, and management, and adds value to the organization.

The external Quality Assurer (QA) will assess all internal audit activities, such as but not limited to annual work planning, including use of resources; various types of audits pertaining to function, directly implemented projects; audit follow-up system; advisory services; coordination with external auditors; relationship with senior management, Audit Advisory Committee.

QA will also assess the organizational status and mandate of Internal Audit Unit as well as the proficiency of Internal Auditors.

The following activities will **not** be covered:

- (i) Investigation services, as this is subject to a separate external quality assessment; and
- (ii) Review and assessment of audit reports prepared by third party auditors, as this is not strictly speaking on assurance activity.

REPORTING

External Assessment Report

1. The External assessment report shall include, but not limited to, an assessment for each standard and an overall assessment for each standard series (attribute and performance). The following minimum rating scale shall be included in the report:
