### 3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

- The contractor must ensure that all personnel/ labour are wearing appropriate PPEs and OHS is adhered to at all times.
- The contractor must have valid or active insurance cover to repair or restore all structures and property that may be damaged or disturbed during performance of the work to the satisfaction of the UMzimvubu municipality.
- The contractor shall supply all Occupational Health Safety and Environmental (OHSE) Compensation for Occupational Injuries and Diseases Act (COIDA) related information required on the Municipality Contractor Induction form before commencement of operations.
- The contractor must include the proof of insurance, methodology and time frames.

## 2. TREE REMOVAL WORK

- The contractor shall protect sidewalks, driveway, and manhole from the impact of falling wood using limb ground supports or ropes when needed.
