I take this moment to welcome you all whom have attended this last Ordinary Council meeting in the year 2018.

You will note that there have been numerous postponements of this Ordinary Council meeting due to the various events such as, Strategic Planning's that we had to attend to

as you all know that the month of November and December are extremely eventful. This therefore serves as a sincere apology for the postponements.

Three days from today we will be celebrating the Reconciliation day, a day that was celebrated as a public holiday in 1995 as it acknowledged the 16 December 1838 when the Battle of Blood River took place between the Voortrekkers and the Zulus. In that Battle of Blood River approximately 500 Voortrekkers having an advantage of gun powder managed to defeat 10 000 Zulu army.

You will recall that since then the Voortrekker victory was commemorated as the day of the Vow.

The second historic event took place on the 16 December 1961 when the military wing of the ANC known as Umkhonto We Sizwe was formed, exactly after the Sharpeville massacre in 1960, where peaceful protesters were brutally ambushed by the apartheid government.

South Africa's first non-racial and democratic government was tasked with promoting reconciliation and national unity. Therefore, it acknowledged the significance of both the Afrikaner and liberation struggle traditions and thereafter renamed this day as a Day of Reconciliation.

Councillors, as we all know that we are approaching the National Elections next year, there has been numerous protests around Umzimvubu Local Municipality, some being legal and others illegal but nevertheless, the most fundamental cause of these protests is the inappropriate provision of Service Delivery in our communities.

It has become a norm that whenever we are approaching elections, protests will come into effect, how do we then minimise such act from occurring?

- (a) It starts by having a Council that clearly understands the reason of its existence, we are here to serve the interests of our communities.
- (b) As this Council we must at all times have close interaction with our communities in particular the ward Councillors for the purpose of information sharing as well as accountability.
- (c) Monitoring of the effectiveness of municipal structures namely Ward Committee meetings, it has come to my attention that some Ward Councillors don't attend Ward Committee meetings, therefore Ward Councillors should ensure that Ward Committees conduct meetings in their respected villages to inform people of service delivery related matters.
- (d) There should be direct intervention programs for Councillors, namely Batho Pele Principles, Communication Strategy and Council Procedures etc.

Councillors, this Council has managed to conduct the mid-term IDP Outreach program successfully except for only one Ward that dismissed and interrupted the proceedings.

Councillors, we are in the Summer Initiation Season, as of today the reports that have been submitted to the Office of the Speaker indicate that in Matatiele there has been at least three deaths of initiates and one death in Mbizana, but in Umzimvubu no deaths have been reported.

As this Council we are grateful of the determination and good work done by Chief J.B Makaula, Chief M.E Gogela, Cllr M Jolobe and the entire Initiation Committee in ensuring that all initiates come back home safe.

Councillors, it is a great honour to inform you that our young girls are fully participating in the Inkciyo programs and as a result they have been invited to the provincial Inkciyo program in Bisho, they are led by Chief Nosizwe Makaula, Chief Z Sodladla, Chief Rolobile and Chief Nonyaniso Fikeni.

Their work and determination can never go unnoticed.

It has just been reported that in Ward 04, Ngonyama Village, a house has been burnt down and two siblings have been brutally killed, the police are still investigating the reason behind such a cruel act.

The Moral Regeneration Movement will attend to this crisis with immediate effect.
