I am very much humbled with your presence here today, I take this special opportunity to greet all in the name of The Father, The Son, and the Holy Spirit.

The book of Isiah 9:6 "For to us a child is born, to us a son is given, and the government will be on his shoulders. And he will be called Wonderful Counsellor, Mighty God, Everlasting Father, and Prince of Peace". May the Good Lord bless us all, Amen!!

The month of June under the theme; "live the legacy: towards a socio-economically empowered youth, served 42 years remembrance of the young people of 1976. We should focus on Youth development.

Youth development is essential to helping the youth of our locality.

The majority of our young people are unemployed according to the Institute for Management Development (IMD) World Competitiveness 2018 statistics South Africa stand at 65%, unskilled, some cannot even afford to further their studies or even become specialised and it is of that reason that we should pave a way for their development.

Understandable, it is a national crisis but youth development programs can make a huge difference in their lives, this will be an opportunity to advance their education and make a difference in their communities.



The young people are the future of this country.

This year is the centenary, it is 100 years of Tata Madiba and Mama Sisulu, these are two struggle giants who we celebrate with the theme legacy', we will never forget their self-sacrificing struggle for a better south Africa.

If it went for them we wouldn't been seated here today.

The month of July is Nelson Mandela month, a time when people around the world celebrate the life of former president Nelson Mandela by doing small acts of kindness for those who are less fortunate, this is the time when we acknowledge and celebrate the legacy Mandela created to unite South Africa and foster Ubuntu in our hearts as South Africans.

For the 67 minutes of Mandela as Umzimvubu in partnership with ANDM and the Provincial Department of Government Communication & IGR conducted a 100 men march.

This concept was nationally launched in 2011, it's a campaign that recognises men as critical partners and role players in advocating gender equality.

Men should take a stand and fight patriarchal values that lead to violence against women and children as well as to promote an open dialogue about economic/financial instabilities that cause men to be insecure/ violent.

The recent reports indicate that women and children in South Africa continue to bear the brunt of violence and abuse, mostly in the hands of men in their lives.

This campaign promotes the centrality of the role of men in preventing violence against women and children.

It also aims to galvanise men across all sectors of society to respond to President Cyril Ramaphosa's "Thuma Mina" call by committing themselves to play their part in ending violence and abuse.

Chapter 2 under the Bill of Rights, Section 29 of the Constitution of the Republic of South Africa, Act 108 of 1996 outlines that everyone has a right to;

A basic education, including adult basic education and to further education, which the state, through reasonably measures, must make progressively available and accessible. The Provincial Education Portfolio Committee has visited both Alfred Nzo West and East. Critical aspects facing our education in both these education districts were addressed, namely; water and sanitation as the department of education is seating with a budget for sanitation underutilised. Transport systems and Infrastructure still possess a challenge.

Colleagues, A claim was processed under the Redistribution of Land Rights Act No. 22 of 1994.

Section 25 of the Constitution of the RSA, Act No.108 of 1996 stipulates that no one may be deprived of property except in terms of law of general application, and no law may permit arbitrary deprivation of property may be expropriated only in terms of general application — for a public purpose or in public interest and subject to compensation, the amount of which and the time and manner of payment of which have either been agreed to by those affected or decided or approved by court.



In concurrence, with the above legislative framework the community of ward 25, National Department of Rural Development and Agrarian Reform and Umzimvubu Local Municipality have successfully handed over disposed land.

The title deed handover to the ImiKhonde community was reigned by the Minister of Rural Development and Agrarian Reform.

Out of 850.4659 hectares dispossessed for 161 ha will be used for residential land which will benefit ImiKhonde claimants and Mangqamzeni community members 689.4659 ha will be used for developmental purposes and agriculture to benefit these communities.

The Department of Public Works have committed itself to provide skills to the communities and as Umzimvubu Local Municipality we will have to make contributions to this effort.

Chapter 7 on Local Government of the Constitution of RSA section (e) reads as follows, 'to encourage the involvement of communities and community organisations in the matters of Local government.

It is of that reason Umzimvubu Local Municipality have staged a successful Imbizo in ward 23.

As per the Back to Basics document in order for public participation to succeed, public representation should close ranks of social distance between its constituencies.

The month of July has been eventful with stakeholders engagements programs in place where the office of public participation established PSC's for the 2018/2019 projects in ward 20,18,01,26,05,12,02,11,23,22

Section 72 of the Municipal Structures Act provides for the establishment of ward committees.

Section 16(1) of the Municipalities Systems Act requires that a municipality must develop a culture of municipal governance that complements formal representative government with a system of participatory governance, Ward Committee Bi-elections were successfully conducted in Ward 20, Ngxabaxha village.

The petitions committee with all relevant stakeholders affected in the complaint submitted by the community of Matyeni in Ward 14 has successfully attended to their cry and they visited the community last week.

We are grateful of the presence of our traditional leaders in municipal programs, their attendance dignify our events. For, instance let me congratulate Chief Didi Makaula for his selection to represent Umzimvubu in the SAIMSA games in Swaziland.

On the 23rd July the Eastern Cape Province conducted a Public hearing on the expropriation of land without compensation in Umtata.

A delegation of traditional leaders and councillors represented this council in that fruitful event.

These are the names of the of those who attended the public hearing, Chief Mdutyana Sogoni, Chief M.E Gogela, Chief M. Nota, Cllr T Nomkuca, Cllr M Joloba, Cllr Ntsevu and other stakeholders.



An extract from a local newspaper takes through to the view of other African leaders and scholars on the issue of land in South Africa.

The Kenyan intellectual Professor Patrick Lumumba delivering the Nelson Mandela Memorial lecture at Walter Sisulu University Mthatha campus said,

"Nelson Mandela would have reminded us that the last colonial question is land. If you don't tackle the issue of land, you shall never know peace,"

The land question has become a hot potato in South Africa following the ANC December conference at Nasrec, which adopted the policy of land expropriation without compensation.

Lumumba continued reminiscing that if Mandela was among the people celebrating the centenary he would have asked numerous important questions, including that of how a continent like Africa, rich in mineral resources, continues to be poor.

"He would have asked how is it that our continent that is so endowed produces what it does not consume and consumes what it does not produce.

He would have asked whether the continent of Africa is really liberated.

Nelson Mandela would have reminded us that we Africans have suffered more," Lumumba said.

He said the time had come for Africa to cleanse itself and deal with corruption, as Mandela would have liked.

"The time has come we must do away with dealers and have leaders, do away with cheaters and have teachers instead.

He would have posed the question: 'How is it that corruption is still a scourge in our continent?' Madiba would have told us to unite," he said.

The remarks of the former president Thabo Mbeki on the land issue clearly state that South Africans are not yet keen to work the land and, as he alluded he takes us on a report in western Cape of Zimbabwean teachers who borrowed a farm from a white farmer.

The farmer had deserted his farm because the soil got exhausted and he felt that it would be costly for him to buy fertilisers so as to re-work the farm.

The farmer was convinced that the land is extremely bad. After these Zimbabweans has worked the land they were announced as South Africa's Farmers of the year in the Western Cape.

Their trick was to use (Manyor) instead of chemical fertilisers. It's a good story to tell since its Africans but we must note its Zimbabwean's not South Africans.

As South Africans we have a negative attitude to land for instance the majority of those who make land claims prefer to be paid huge sums of money rather than to take the land and work it.

I just thought I should share these sentiments with you and maybe later on we can debate on the matter. Maybe we can even come up with strategies that can change our mentality towards land as South Africans.

Lastly, the Winter Traditional Initiation School Season is finished and as Umzimvubu on our side, no deaths were reported and all challenges faced were attended to successfully.

Let's further congratulate the visibility of our Traditional Leaders, Chief J.B Makaula and Chief M.E Gogela for their tireless effort in ensuring that the program was a success.

- 7. That the Budget and Treasury Unauthorized, Irregular, Fruitless & wasteful expenditure report for the month of 31st May 2018 be noted by the council.
- 8. That all tenders awarded by the bid committees appointed from 1st July to 31st May 2018 be regularized by Council and the irregular expenditure incurred thereof be written off by Council.
- That irregular expenditure resulting from appointment of bidder through Regulation
 for electrification projects, is written off by Council, as Nyandeni LM was affected by the same Regulation 29 Non compliance.
