Today marks the last Council in the financial year 2017/2018 and it is therefore the budget Council meeting, where we will deliberate on the income vs estimated expenditures, adoption of the Integrated Developmental Plan a program initiated to be an ear to exactly what the people want and wish for where service delivery is concerned and furthermore, as the Council to consider the approval of the annual budget as stated in the Municipal Finance Management Act No. 56 of 2003, section 54(1).
