Specification for Removal of Emsukeni container library

1. Removal of Msukeni container Library from Msukeni Community hall to Msukeni Arts center
2. Estimated distance 900m
3. Connect electricity
4. Fix 5 broken window panes
5. Fix broken door handles

Concrete slab

Clear 6m x 3m

- Mark out and Excavate
- Foundation 6m x 2.5m x 500mm deep
- Supply and cast 17m x 500mm x 200mm 25mpa concrete
- Supply and build double line cement stock bricks 6 lines to slab height
- Supply and fill foundation with sabunga and compact in 150mm layers
- Supply and lay concrete underlay green pvc plastic
- Supply ref 193 mesh
- Supply and cast 100mm 25mpa concrete and float
- Plaster outside of brickwork and paint when dry.
