1. Introduction:

2. Scope of Work

A suitable qualified service provider is required to supply, deliver and install an irrigation system at the Lugangeni feedlot project and the following guidelines should be strictly adhered to:

- Construct two catchment form natural springs.
- Dig 0.0m and lay 950m of 35mm HDPE plastic pipe to the 1000l reservoir (Jojo tanks).
- Connect an over flow pipe to the bottom water basin.
- The service provider must hold a deep seated knowledge of the water requirement and specific standard for connecting natural water spring to the reservoir.
- The design should have valves that are hand operative and the whole system must be easily dissembled whenever necessary.
- The system must also be equipped with backflow preventers.
- The provider should provide one day training to the beneficiaries on how to manage an irrigation system.

3.1 The service provider will account to Umzimvubu Local Municipality LED Department.

A Project Manager from the Municipality who is an LED Manager will be responsible for all the executions/Deliverables during the process of the project.
