TERMS OF REFERENCE

TO DEVELOP MARKETABLE TOURISM MAP FOR UMZIMVUBU TOURISM PRODUCTS

1. Introduction:

- 1.1 Umzimvubu Local Municipality Local Economic Development & Environmental Management Department has 5 areas of performance of which one of them is Tourism
- 1.2 Umzimvubu Local Municipality is aiming do develop a marketable tourist map
- 1.3 The aim of developing the tourism map is to give directions to Umzimvubu visitors
- 1.4 Umzimvubu Local Municipality therefore is looking for a service provider that will develop a tourist Map for the 2018/2019

2. Project Situation

The project is situated in Umzimvubu area of Jurisdiction

3. Request

Umzimvubu Local Municipality is looking for a service provider that will develop a tourist map for the 2018/2019 Financial year.

Comprehensive Proposals with financial costs for this exercise

4. Scope of Work

- 4.1 The service provider will have to develop a tourist map of all tourism products ranging from natural attractions, man-made attractions, craft centres, Information centres, Trading centres and heritage sites
- 4.2 The Map must cover Umzimvubu area of jurisdiction, all 27 wards and be placed in a digital form.
- 4.3 The Map must show streets, street names, co-ordinates, distances from the national roads
- 4.4 The service provider must develop 300 copies of tourist maps
- 4.5 The service provider to ensure that there are absolutely no errors at all on the final print of the Map failing to do so there will be heavy penalties.
- 4.6 The scale of the Map is 1:1000 and be folded into a pocket size
- 4.7 The Map must have information signs
- 4.8 A master copy of the tourist map must be submitted to the municipality
- 4.9 Page must be glossy and colorful
- 4.10 The municipality will not be providing personnel to visit these attractions nor the transportation however telephone numbers and directions will be provided
- 4.11 Important Contact numbers to appear at the back of the map (eg; SAPS, Hospitals, Municipalities both district and local etc)
- 4.12 Copies must be branded with Umzimvubu Logo
- 4.13 Copies must be written Visitors guide

5. Accountability and Reporting Structure

- 5.1 The service provider will account to Umzimvubu Local Municipality LED & EM Department
- 5.2 The service provider must submit work done on stages to the LED & EM Department for Approval.
- 5.3 The municipality has a patent right on the Map, therefore selling and duplicating is prohibited.

6. Project Management

A Project Manager from the Municipality who is an LED & EM Manager will be responsible for all the executions/Deliverables during the process of the project. She/he will work with the Consultants/Service Provider from the start until the completion of the Project. She/he will ensure that all the deliverables stated above are met/executed, However the LED Manager may from time to time second personnel to assist whenever this deemed necessary.


