PROJECT SPECIFICATION

1. Scope:

This specification covers the marking of road surfaces in accordance with the standards and specifications of Umzimvubu Local Municipality and the SOUTH AFRICAN TRAFFIC ROAD SIGNS MANUAL. The rates quoted will include all labour and equipment (sprayers, brushes etc) required for the marking of roads as well as for the setting out and pre marking work. The preferred method of application will be spraying, but brush painting will also be considered. Digital photographs (before and after, with imprinted dates) must also accompany invoices, before payments will be considered.

2. **Interpretation:**

2.1 Supporting Specifications: The following specifications shall, apply:

- a.) This project specifications.
- b) SOUTH AFRICAN TRAFFIC ROAD SIGNS MANUAL
- c) SABS 1200AA: General (Small Works)
- d) SABS 1200AB: Engineer's Office
- e) SABS 1200C: Site Clearance.
- f) SABS 1200MM: Ancillary Roadworks

2.2 The variation and additions to the specifications listed in 2.1 are as follows:

a.) PSAA: General (SABS 1200 AA)

PS8: Measurement and Payment

No measurement for payment will be included here. The scheduled items listed elsewhere shall include full provision to cover the contractor's charges for compliance to the requirements under this specification.

b.) PSAB: Engineer's Office (SABS 1200AB)

PSAB 2.3: Definition

The Engineer is the Roads and Storm water Section of the Employer.

PSAB 3.2: Office Building: This is not required.

PSAB 4.1 Telephone

A cellular telephone must be provided by the Contractor on site in order to ensure adequate communication.

c.) PSC: Site Clearance (SABS 1200C)

PSC 3.1 Disposal of material:

Sand, gravel and other material obtained from the cleaning of the road surface may only be disposed of at the nearest dumping site as indicated by the Engineer.

PSC 8 Measurements and Payment:

The areas to be cleared and the disposal of the material will not be measured separately for payment. The rate for the work to be done will cover the cost to comply with this specification.

d) PSMM Ancillary Roadworks (SABS 1200MM)

PS 8 Measurements and Payment:

No additional payments for variations in rates of application or for setting out and pre-marking will be measured separately for payment. The rate for the work to be done will cover the cost to comply with this specification.

3. Schedules:

Marking of road surfaces (painting) as per the South African Traffic Signs Manual, and SABS 1200

- 1. Standard road marking paint to be provided by the municipality. The rate must include labour and equipment.**
- 2. In this project two service providers will be appointed, one service provider for Mount Ayliff town, and one for Mount Frere town.**
