STAND DESCRIPTION

The service provider's cost for to the work must consider for supply and deliver for all necessary required materials including cost for equipment and labour and allow for profit to carry out the work.

6000 x 3000mm x 300mm high Container Stand

Remove topsoil 7000 x 4000 x 150mm deep average and spread it on site, excavate trench size 18000mm long x 600mm wide x 600mm deep and cast 250mm thick of 15MPa mass concrete footing, brick up 220mm concrete brick wall size 18000mm long x approximate 700mm high from footing to protrude by at least 300mm high from natural ground level with suitable brick force in each and every course including filling up under floors with imported approved suitable material compacted to 98% Mod ASSHTO and lay 250 micron dpm underfloor and box up to make formwork for to cast 20MPa 100mm thick reinforced concrete surface bed, concrete reinforced with Ref 195 mesh including floating with wood float including construction of access ramp with suitable gradient.
