TERMS OF REFERENCE FOR APPOINTMENT OF A SERVICE PROVIDER TO UNDERTAKE AN AWARENESS CAMPAIGN ON ELECTRICITY USAGE IN SUPPORT OF THE ENERGY EFFICIENCY STANDARD AT UMZIMVUBU LOCAL MUNICIPALITY 18 WARDS

1. BACKGROUND

Umzimvubu Local municipality in collaboration with Eskom supply on monthly basis all indigent households in the jurisdiction of umzimvubu with free 50 kHz basic electricity. This is done through the Council approved indigent/free basic services policy. The municipality consist of 27 (18 electrified and 9 unelectrified). Therefore there are 18 wards benefiting from free basic energy and the remaining 9 wards are benefiting from non-grid energy (Solar and Paraffin).

The municipality initiated an awareness campaign program to electrified villages. The program is primarily aimed at contributing towards the reduction of dangerous usage of electricity and load shedding in the electrified villages of Umzimvubu Local Municipality. Encourage local suppliers to sell efficient appliances and equipment.

It is foreseen that there will be many benefits to be gained from this programme, to name a few; suppliers should see a notable increase in sales, Eskom should see a reduction in peak demand and electrical use, Customers should see a reduction in electricity bills and the environment should gain in terms of emission reductions.

The programme is intended to run for a period of least five days.

2. OBJECTIVES

The objective of these terms of reference is to educate electrified villages about dangerous of electricity, load shedding. Increase the uptake of energy efficient appliances to the community of umzimvubu local municipality

3. SCOPE OF WORK

The service provider will be under the overall supervision of Umzimvubu Local Municipality Municipal Manager and his/her daily work will be coordinated with the FBS/indigent coordinator.

The successful service provider will ensure that the expected outputs are completed on time and comply with the specific project criteria and requirements. The scope of work will include the follow:

- i. Advise the organisers on the process of the awareness campaign
- ii. Design an appropriate process of the awareness campaign leading to the desired results
- iii. Facilitate the awareness campaign
- Engage all electrified municipal wards (18 wards) on dangerous usage of electricity and load shedding
- v. Encourage people to buy and local suppliers to sell efficient appliances and equipment
- vi. Produce the awareness campaign documentation /material & carry out the final analysis report for umzimvubu locality
