#### **Terms of Reference**

Project Name: Biodiversity profiling for EmaXesibeni Botanical Gardens exhibition center (EBGEC)

Services: Provision of consultancy services to conduct an ecological/biodiversity and species profiling for EBGEC in the Umzimvubu Local Municipality.

The Umzimvubu Local Municipality in its quest to conserve the environment and to reclaim the natural ecosystem have earmarked or reserved +/- 10 hectares of urban land for establishment of a Botanical Gardens. The initiative is aimed at addressing the issues of restoring ecosystems. The proposed area is in the build-up urban area and will be integrated to the existing developments which are as follows:

- 1. Ntsizwa Eco Park
- 2. Mount Ayliff old cemetery (Monumental site)
- 3. Bridge Complete Green Street.

This establishment will provide knowledge and expertise in plant taxonomy, horticulture, biodiversity inventory, conservation biology, restoration ecology and ethnobotany.

This Botanic garden will also collectively serve as a Local and District Municipality repository for documented plant material, with at least one-third of all flowering plants maintained in living collections or seed banks. Utilizing knowledge gained from these collections, related herbaria and libraries, and combined with landscape knowledge from field surveys and ecological research, which will bring the understanding necessary to ensure that restoration leads to adequate taxonomic diversity and incorporates appropriate genetic provenance.

With this initiative the Municipality is also aiming to restore diverse and ecologically resilient places, avoiding the dangers and pitfalls associated with growing inappropriate plants in the wrong environment.

#### 1.1 Project Aims

To conserve biodiversity while ensuring that local communities directly benefit from the protection of their natural habitat.

To study relationships between plants and publish taxonomic review

To identify and name plants

### 1.2 Project Objective

The research will ascertain, identify and record core habitat and species occurring at Umzimvubu Local Municipality and map how this connects with surrounding Umzimvubu Local Municipality.

The following methods or scope of work is proposed:

### 1.2.1 Virtual Biodiversity Software Tour:

As such, the list below covers the main tasks but is not exhaustive:

- Conduct Aerial View Videography on specified projects in line with the supplied content.
- Conduct site visits and develop voiceover narration of each biodiversity project supplied. These are to be recorded in the following languages:

#### **English and Xhosa**

- Manage project from idea generation to delivery of final product Develop a detailed production plan
- Source appropriate voice over artist/s (including cost of) Voice Over script
- Outline shots to be taken
- Prepare specific areas or rooms to be photographed
- Filming of the entire TIH STP Precinct (360 Virtual Reality Tour)
- Filming on location and x2 other location outside Botanical Garden Exhibition centre and Maximum Digital
- Develop treatment, the loo and tone of the virtual reality tour Descriptive text (to be very limited)
- The virtual tour package to be embedded on the TIH website and a link to social media to direct to our website
- The Virtual tour package must consist of high-resolution photographs brought together in a complete tour package
- The user must have full control over what they want to look at, allowing for them to zoom in and out, respective places or areas to enhance the scene they are viewing
