- Curriculum Vitae of staff and principal partners that are to be involved in the project.
- Method statement and programme of action (clearly stating execution methodology; the project starts and finish dates and major milestone achievable)
- List of projects of similar nature undertaken with clear contact details of references.
- Signed returnable bid document filled with blank ink.
- Bidders must be registered with CIDB grading as indicated in the table above and proof must be attached however they will be confirmed / verified in CIDB website
- BBBEE Certificates issued by verification agency accredited by SANAS original / certified copies must be attached and failure to do so will result in loss of points, if entered into JV agreement combined BBBEE certificates to be attached.
- Tenders which are late, incomplete, unsigned or submitted by facsimile or electronically, will not be accepted.
- Tenders submitted are to hold good for a period of eight (12) weeks.
- Tenderers must be registered as a supplier/service provider on the Umzimvubu Local Municipality supplier/service provider database, if not already registered.
- Billing clearance certificate or statement of municipal accounts.

PRE – QUALIFICATION

All bids will be subjected to a pre-qualification and will be required to achieve a minimum of 60% in order to be evaluated further.
