TERMS OF REFERENCE

TRAINING OF UMZIMVUBU WARD COMMITTEES ON WARD COMMITTEE GOVERNANCE

1. Target Group

Two hundred and seventy (270) Ward Committees to be trained.

2. Goal and Content of the Training

The learners entering this qualification may come from various backgrounds and will be persons who have been nominated by their community onto a Ward Committee to represent the needs of the community, while archiving municipal objectives. It will create an opportunity for the learner to be exposed to various municipal processes and pursue a learning pathway in counselling for Local Government. The qualifying learner will be able to participate actively in overall democracy through proactive community involvement in local government processes.

The purpose of this training is to enable the Ward Committees to apply relevant competency required for proactive participation as a Ward Committee Member so that they achieve municipal objectives.

The learning outcomes contained in this qualification are based on the competencies required to contribute to the effectiveness of municipal processes from a Ward Committee perspective. These relate to:

- Conducting or participating in formal and informal meetings to achieve Ward Committee objectives.
- Involvement in and giving advice on municipal projects.
- Assisting in implementing municipal objectives and overall objectives of Local Government by displaying an understanding of core municipal functions as they relate to Ward Committee context.
- Facilitating relations between Local Government and citizens to effectively support the implementation of its objectives.

2.1. The content should cover but not limited to the following aspects:-

- Application of communication, interpersonal and conflict management principles in Ward Committees. clergy
- Demonstrate an understanding and apply the broad principles of Ward Committee functioning to participate in municipal processes.
- Display an understanding of the Constitution, structure of Ward Committees and the roles and responsibilities of committee members.
- Support the facilitation of development project service delivery in a Ward Committee context.
- Display an understanding of the policy and legal framework guiding the Ward Committee System and its functioning.
- Application of Batho Pele principles to own work role and context.
- Display an understanding of core municipal processes and Ward Committee participation in these processes.
- Advocate and lobby for community issues.
- Plan and prepare for meetings.
- Demonstrate knowledge of gender, equity and diversity issues in development projects.

3. Duration

This exercise has to be done and completed within a maximum number of seven (7) days upon appointment.

4. Methodology

- 4.1 The course should be engaging and interactive.
- 4.2 Feedback and tips for improvement should be given to each of the participants.
- 4.3 The service provider must ensure that the competency assessment is done to all participants.
- 4.4 All participants should also be given training material.

- 4.5 A detailed close-out report for the work done should be submitted at least one week after completion of the training.

5. PROPOSAL SUBMISSION REQUIREMENTS

6.1 List of Contents

All proposals must cover the following aspects of importance:

6.1.1 A Detailed Company Profile

Including brief history, field of expertise, staff resources, a proven tracking record of conducting trainings, where the main office is based as well as any other offices and a list of recently completed projects.

6.1.2 Proposed Methodology

Service provider should come up with a sound and workable methods for the development of the above.

6.1.3 Proposed Cost Structure (Business Plan)

Detailed Breakdown of Proposed Fee Structure, and there should be a clearly stated whether it's inclusive of VAT or not.

6.1.4 Expertise Required:

Due to the urgency of delivery, the scope requires a service provider to drive this project, in conjunction with necessary stakeholders and all other relevant interested and affected groups.

All the required professional team should be involved from the beginning.

6.1.5 Compulsory Terms and Conditions

A proposal will not be considered unless the service provider furnishes the ULM with the duly completed documents mentioned below. In the event that a proposal is submitted by a consortium/joint venture, each party, consultant and or sub-contractor of such consortium/joint venture must complete each of the documents mentioned below:-

- a) Proof Ownership
- b) Declaration of Interests
- c) Tax Certificate

- 6.1.6 The consortium submitting the proposal must declare any conflict of interests that it may have.
- 6.1.7 The ULM reserve the rights, not to accept any proposals in part or in whole
- 6.1.8 The ULM reserves the rights to suggest partnerships or joint venture to be formed between bidders, or that the assignment must be awarded to an exclusive BEE firm.
- 6.1.9 The ULM reserve the rights to amend any conditions, validity period, etc. in the event of material changes to the procedures, all parties will be duly notified and be dealt with transparently and equitable.
- 6.1.10 Successful bidders will need to be prepared to commence work within 14 working days of being informed of the awarding of the tender.
- 6.1.11 Failure to comply with these conditions will result in the invalidation of the proposal and subsequent expulsion/termination from the process.
- 6.1.12 Successful bidder will be required to submit a detailed close-out report.

6.1.13 The guidelines contained in the Umzimvubu Local Municipality Supply Chain Management policy will apply.


