- Documents to be filled with black pen.
- Tenders which are late, incomplete, unsigned or submitted by facsimile or electronically, will not be accepted.
- Tenders submitted are to hold good for a period of eight (8) weeks.
- Tenderers must be registered as a supplier/service provider on the Umzimvubu Local Municipality supplier/service provider database, if not already registered.

- Billing clearance certificate or statement of municipal accounts.

Umzimvubu Local Municipality does not bind itself to accept the lowest tender or any other bid whatsoever.
