#### Introduction.

- Umzimvubu Local Municipality LED Department has the 5 areas of performance of which one of them is Agrarian development /reform.
- The aim is to promote Agricultural activities to fight poverty.
- To promote the local economy. The scope of the Municipality (LED) mandate is the eradication of poverty, by harnessing resources for community-based projects or initiatives.

#### Request.

Umzimvubu Local Municipality is therefore requesting the services of a service provider to conduct tilling, ripping and planting of 20 hectares for the planting of maize fields.

Therefore; **Umzimvubu Local Municipality** invites prospective service providers to submit.

#### ALL-INCLUSIVE QUOTATIONS.

For tilling, ripping, ploughing and weed spraying of 20 hectares of maize fields in 11 wards of Umzimvubu Local Municipality. The quotations for each ward should be submitted separately.

### Scope and Extent of work

The successful Service Provider shall be expected to cover amongst other things.

- Ploughing of 20 hectors maize fields.
- Executing of 20 hectors within 10 (ten) days.
- Daily written reporting or updates (logbook). N.B failure to do this will result in the municipality forfeiting a 10 percent amount of the total, as this is part of the scope of work.
- Estimations per hectare are as follows, but subjected to laboratory results from soil samples.

**DELIVERABLES**

The main project output is ploughing of 20 hectors of maize fields in the above mentioned wards.

The area should be tilled and ripped in such way that it is ready for ploughing after the operational.

**Project Management**

A Project Manager from the Municipality who is an LED Officer will be responsible for all the executions/Deliverables during the process of the project. He will work with the Consultants/Service Provider from the start until the completion of the Project. He will ensure that all the deliverables stated above are met/executed, However the LED Manager may from time to time second additional personnel to assist when ever this deemed necessary.

The affected Ward Councillors will be responsible with the identification of the 11 wards, every 20 hectares to be ploughed must not be scattered. A service provider will be employed to count the 20 hectors in the 11 wards.

A Project steering Committee will be chaired by the Project Manager who is an LED Officer of Umzimvubu Local Municipality. Local Agricultural Extension officer, Ward Concillor, and Local Authority

**Project Duration**

The time for finishing 20 hectors should not be more than 10 (ten) days.

### **Quotation Route Acquired by Supply Chain Management (SCM)**

Umzimvubu Local Municipality's procurement, thus Supply Chain Management will acquire quotations from relevant eligible Service Providers to conduct ploughing of 20 hectares of maize fields in 11 wards of Umzimvubu Local Municipality. And the Service Provider will be expected to furnish us with.

- Methodology and functionality, stating the exact time frame for starting and finishing which shall be within the allocated time of 4 days, from the date of receiving the order.
- Proof of ownership of the tractor will be needed. N.B physical verification will be conducted by the relevant office.
- Founding statement ( CK) of the company
- Original Tax Clearance certificate should be included in the quote.
- BBBEE certificate
