
SUBJECT : REQUEST FOR QUOTES: CONVERSION OF BREAKDOWN TO STRAY

ANIMAL IMPOUNDMENT TRUCK.

This communiqué serves to request your office to solicit quotes from suitable service providers for the conversion of the breakdown to **stray animal impoundment truck**. The old breakdown needs to be converted to be a truck used to fetch stray animal along public roads

Quantity	Item	Description
1	Drop sides and railings fitted to rollback truck.	To build up drop sides and fit onto load body 450mm high with hinges and latches (on side of truck) build up cattle rails and fit to truck 1.7 meters high (a total of 2.2 meters). This will include 2 sliding gates. To build up ramp for rear loading operated by the winch. Buildup 4 gates to be attached to back for easy loading. The gates will be attached to side of rails. Everything to be painted white.
