tem	Description	Size
1.	Clearing of soil and leveling in the back and western side of the building	25m x 3 meters
2.	Planting of kikuyu grass in the back and the western side of the building	25m x 3 meters
3.	Leveling and application of 35mm Mass concrete pavement from the gate to the building veranda. The pavement should be decorated on both sides with white stones with a diameter of 50mm.	22 meters x 1.5 meters
4.	19mm mass concrete, skirting linking the already existing skirting to the pavement	15 meters x 1.5 meters
5.	Decoration of the space between the pavement and the linking skirting with white stones with a diameter of 50mm and planting of 10 evergreen indigenous shrubs.	20 m ²
