Introduction:

- Umzimvubu Local Municipality LED Department has the 5 areas of performance of which one of them is Agrarian development.
- Umzimvubu Local Municipality aims at promoting and boosting the local economy through Agro –processing business entities.
- Umzimvubu Local Municipality aims to create a conducive environment of local SMME's and business entities.
- Umzimvubu Local Municipality therefore is looking for a service provider that will supply, deliver and peach orchard irrigation system.

2. Project Situation

The project is situated in wards 01, Pakade of Umzimvubu area of Jurisdiction

1. Request

Umzimvubu Local Municipality is looking for a service provider that will supply, deliver and install the peach orchard irrigation system.

Comprehensive Proposals with financial costs for this exercise

2. Scope of Work

A suitable qualified service provider is required to supply, deliver and install an irrigation system at the peach project in an area of 3 hectares and the following guidelines should be strictly adhered to:

- The service provider must hold a deep seated knowledge of the water requirement and the irrigation scheduling of fruit trees and specific standard crop factor thereof.
- The service provider should install irrigation with emitters that conform to minimum cost effective water usage preferably drip emitters. The water flow should be reduced from at least a pipe diameter of 50mm from the water source.
- Water distribution should be uniform throughout the channels and tubing should not be buried.
- The design should have valves that are hand operative and the whole system must be easily dissembled whenever necessary.
- The design of the system elevation should be at least 5 meters above the ground level to allow the gravity force feed or else to channel the elevation of the water source to such elevation. And must be able to convince the officials with scientific facts as to how the service provider has calculated such an elevation.
- Each channel should be regulated such that it irrigates independent others.
- The system must also be equipped with backflow preventers.
- The provider should provide one day training to at least five beneficiaries on how to manage an irrigation system.
- 3. Accountability and Reporting Structure
 - 3.1 The service provider will account to Umzimvubu Local Municipality LED Department

4. Project Management

A Project Manager from the Municipality who is an LED Manager will be responsible for all the executions/Deliverables during the process of the project. She/he will work with the Consultants/Service Provider from the start until the completion of the Project. She/he will ensure that all the deliverables stated above are met/executed, However the LED Manager may from time to time second personnel to assist whenever this deemed necessary.
