- Project experience on building/Civil projects. Minimum three (3) projects. One (1) project undertaken must atleast have been a turn-key contract.
- Tenders which are late, incomplete, unsigned or submitted by facsimile or electronically, will

- Tenderers must be registered as a supplier/service provider on the Umzimvubu Local Municipality supplier/service provider database, if not already registered
